

**Reference: SNTEA-K communication No.SK/NT/V-P/133-163 dated 7.2.2018**

This bears reference to aforesaid communication. In this regard President, SNTEA-K is informed as under:

I.	<b>Grant of due date in Two-Tier CAS</b>	The issue regarding implementation of Clause B(ii) of Two Tier Career Advancement Scheme for Non-Teaching Employees of SKUAST-K in the matter of effective date of Second Upward Movement, was discussed with the prescribed Committee on 06.02.2018 in the office room of Registrar. The representative of SNTEA-K (Mr. Mohammad Shafi) was also present in the said meeting. Since, the Scheme has been notified for adoption and incorporation in the Statutes on the basis of concurrence of Financial Advisor (J&K Universities), followed by recommendation of Board of Management and approval of University Council, therefore, in view of the nature of the issue and the Scheme being simultaneously operative in respect of Non-Teaching employees of two SAUs of the State, it has been decided that the matter shall be jointly referred by both the SAUs to the Financial Advisor (J&K Universities) for advice. Needs to mention that the University administration is not averse to the implementation of the provisions of Scheme within the definition of respective clause under reference, to the extent as may be advised by the Financial Advisor (J&K Universities) in this regard.
II.	<b>Implementation of SRO-311</b>	Regarding adoption/implementaion of provisions of SRO-311 dated 09.09.1997 of GoJK in the matter of counting of 50% continuous work charged/daily wage service with regular service for purpose of grant of in-situ promotion (placement) under Two Tier Career Advancement Scheme for Non-Teaching Employees of SKUAST-K in favour of concerned category of employees in the University, the

<p>III.</p>	<p><b>Grievances of FCLAs and LSAs like due date promotion</b></p>	<p>Regarding the time old issue concerning the Field-cum-Laboratory Assistants/ Livestock Assistants, the matter stands referred to a Committee, duly constituted for the said purpose. The Committee has been constituted to ensure that the issue raised by the concerned category of employees is properly examined as per merits of the case so as to address the issue in a manner as shall be admissible under rules. The details/information sought in this regard by the Committee from time to time have been made available by the Registry to the Committee. In order to expedite the process and submit the report, the Committee has been reminded by the Registry to fast-track the process. However, the Committee has now sought further details on 01.02.2018 with regard to total number of vacancies of Field-cum-Laboratory Assistants at the time of deputing the group of 27 Class-VI category employees for Field-cum-Laboratory Assistant Apprenticeship Training during the Session 1994-1996 as well as total number of vacancies available @ 25% quota on Field-cum-Laboratory Assistant positions as per Statute as on date of deputing the group of Field-cum-Laboratory Assistant Apprenticeship Training, total number of vacancies available at the time of completion of Field-cum-Laboratory Assistant Training by the group successfully and year-wise creation/available Field-cum-Laboratory Assistant positions acquired due to new creation, retirements and death in harness during the period 1994-2005. The issue raised is almost three decades old. Therefore, it needs extensive exercise by the Committee to examine/scrutinize the case to case basis in order to arrive at a logical conclusion. The University shall proceed further in the matter on receipt of the report of the Committee in accordance with the statutory provisions. Pertinent to indicate that the current information regarding promotion of staff indicated at Class-VI Schedule-I to the Chapter-III of Statutes viz: Chowkidar, Orderly, Peon, Messenger, Runner, Laboratory Attendant, Duplicating Operator, Library Attendant, including the staff indicated at</p>

	Class-VI Category-4 of the said Schedule viz: Gardener, Mali and Farm Attendant and also the staff indicated at Class-VI Category-III of Schedule-III to Chapter-III of Statutes viz: Shepherd/ Animal Attendant to the positions of Field-cum-Laboratory Assistants and Livestock Assistants, under 25% quota statutory provision, obtaining as on date, is as under:

VI.	<b>Pay anomaly orders</b>	<p>The issue regarding pay anomaly orders has not been elucidated by the SNTEA-K. However. it is to convey that the notification regarding grade anomaly in respect of Statistician, Medical Assistants and Junior Engineers stands issued vide Notification No:01 of 2018 dated 09.01.2018. Further, the orders regarding removal of pay anomaly in respect of senior Assistant Comptroller and Assistant Registrars by stepping up of their pay stands</p>

		issued vide University Order No:29 (Est) of 2018 dated 08.01.2018 with concurrence of the Financial Advisor (J&K Universities).
VII.	<b>Re-transfer, animosity and lobby system transfers particularly Mr. Mohammad Younis, Accountant</b>	Regarding demand of the Association for re-transfer of staff particularly Mr. Mohammad Younis, Accountant (President, SNTEA-K), it is reiterated that no transfer has been made on animosity basis as has been wrongly projected and highlighted by the President, (Mr. Mohammad Younis), SNTEA-K for himself. The transfer of Mr. Mohammad Younis, Accountant (President, SNTEA-K) and signatory of the aforesaid communication was ordered purely in the interest of administration along with other accounts personnel. He had longest stay at one place. As many as thirty-three (33) Account personnel, which included Mr. Mohammad Younis as well, were transferred vide University Order No:465 (Est) of 2017 dated 19.05.2017 and University Order No:11 (Est) of 2018 dated 03.01.2018. Since then, many transfers/postings of Teaching as well as Non-Teaching staff have been effected on need basis and in the interest of administration and in pursuance to Government Order No:168-F of 2014 dated 14.07.2014.
VIII.	<b>Regularization of DPLs</b>	Regarding the issue of regularisation of DPLs raised by the Association at this point of time, the University has already constituted a Verification Team in this regard. The Team has been tasked with the job of verification of each case of DPLs at respective offices/units where engaged. University cannot proceed ahead unless credible/authentic/verifiable data in respect of genuinely engaged DPLs is available. Pertinent to convey that the case of 71 DPLs is currently under investigation with the State Crime Branch. The University can ill-afford to proceed ahead in this regard, pending decision of the investigating agency nor should the Association intervene in such sensitive issue when the matter is under high profile investigation.
IX.	<b>Promotion of Head Assistants</b>	In so far as the demand regarding promotion against the posts of Head Assistant and ACTs as per statutory provision is concerned, the administration is live to the issue and the case stands already taken up without waiting for any reminder from the SNTEA-K.



X.	<b>Adjustment of ACTs against available promotion quota</b>	Pertinent to indicate that as per 25% statutory quota for promotion of Class-VI Graduate employees having minimum 05 years regular/ satisfactory service in Class-VI category post of the University and subject to passing of type test with speed of (25) words per minute, the type test of eligible Class-VI category employees for promotion to the posts of Assistant-cum-Typist has been conducted on computer key board at NIELIT, Rangreth on 22.01.2018. Further process in this regard is under way.
XI.	<b>Relieving of Comptroller from SKUAST-K</b>	Regarding the demand of the Association to relieve the incumbent Comptroller (Mr.Parvez Sajad, <sup>KAS</sup> on deputation from Finance Department, GoJK), the Association has no locus-standi to interfere in such administrative matters.

In view of the above situation, the ultimatum issued by the President, SNTEA-K for resorting to hunger strike w.e.f 15.02.2018 is unjustified and uncalled for on their part. This act of SNTEAK is against the J&K Government Employees Conduct Rules-1971, ipso-facto, applicable to SKUAST-K employees as well. The Hon<sup>ble</sup> Supreme Court of India in its judgement in TK Rangarajan Vs Government of Tamil Nadu has established that the government employees under no circumstances have any fundamental legal or moral right to go on strike.

With regard to all the demands/issues raised by SNTEA-K, **the University administration, as per statutory provisions, has taken action and/or being processed under rules with Financial/Legal Advisors of the University.** It is in place to mention here that the SNTEAK-K had a detailed meeting with Hon<sup>ble</sup> Vice-Chancellor on 06.01.2018 at his Secretariat and all the issues were deliberated upon. Minutes of which were issued under No: Au/Adm/NTEAK/ 2018/24/81-85 dated January 10, 2018. In principle, it was agreed upon that the next meeting shall be held after a period of three (03) months, but after a passage of only one (01) month, the SNTEAK has chosen to go on hunger strike, which is unjustified and unlawful. Therefore, the President, SNTEA-K is hereby advised to introspect, exercise utmost caution and restrain from such unlawful activities, which may otherwise, lead to the vitiating/disruption of normal activities and peaceful atmosphere within the Institution where interalia educational activities of the UG/PG students, essential and important research/extension programmes are also going on. There are proper ways of ventilating the greivances, if any, within the ambit of law. In case, the Association

continues with the proposed strike, the administration shall have no other option but to proceed against the persons within the ambit of law explained above, who are found responsible for wilful disruption of activities of the University by resorting to unlawful activities starting with Hunger Stike etc and instigating the employees against the administration on the Campus.
