**Notice**

Whereas, in terms of D.O. communication No. F.17-8/2013(PS) dated 1.3.2016 issued by UGC, the period spent in obtaining Ph.D degree is required to be counted as teaching experience for purpose of direct recruitment to the post of Associate Professor and above. But in terms of the following Advertisement Notices it was provided that **"the period spent in obtaining Ph.D degree will not be counted as teaching experience"**:

Whereas, the candidates who had completed Ph.D degree as on last date fixed for receipt of applications indicated as above, but could not apply because of above mentioned restriction, may now be eligible by counting the said period as teaching experience.

Therefore, keeping in view the rights accrued to such candidates, it is deemed proper to invite all such candidates who had completed Ph.D degree as on last date of receipt of applications and were becoming eligible by counting period spent in obtaining Ph.D as teaching experience, are also invited to apply for the suitable post/s, if interested, by or before 20.12.2017 alongwith requisite application fee of Rs. 2000/- for each post, so that their candidature is also considered by the Screening Committee.

Other eligibility requirements/ terms and conditions laid down in the respective Advertisement Notices referred to above shall remain unchanged.

The candidates who will apply shall have to fulfil condition laid down in the D.O. communication No. F.17-8/2013(PS) dated 1.3.2016 issued by UGC.


